## Mayor's Report – Mayor Valdini:

- Lulu Lobster is set to open shortly. The Fire Marshal will be inspecting soon and will hopefully give the final approval for opening. This establishment is a nice addition to the Village.
- We are at the one-year anniversary of COVID. We are working to keep everything as normal as possible while keeping the virus in mind. We are working out the Easter Egg Hunt and Plant Sale currently.
- We will be hiring mature residents for Beach Attendants which is something new for Walker Beach. This position will sell passes, check passes and monitor the conditions of the park.
- We hope the Contractor will be in this week for the bulkhead repair. We will be starting from the North and working their way south. We are hoping to get the first 500 ft repaired by April 15<sup>th</sup> but we will have to see.
- The Mayor, Trustee Fawcett, Bob O'Shea Building Inspector and Kristina Everitt, Office Assistant walked through the Downtown Business District to inspect the exterior property maintenance of all the storefronts. There were three categories that were assessed: Immediate issues to be addressed, short term issues and long-term issues. Each storefront will receive a personalized letter from the Village stating a timeframe and plan to remedy any issues. Some are as little as paint and touch ups but some are more involved. - Met with resident Jane Jonas regarding the lakes. She has been voluntarily working diligently on the Village's behalf in getting different ideas on how to remedy some of the issues around the lakes. She reached out to Sea Tuck about a fish bridge. They will work with the Village in helping with grant writing.
- There is a lot of trash left around the lakes. Trustee Fawcett will be coordinating a Lakes Cleanup day.

## Fire Marshal Report

All Public Assembly and Multiple Dwelling occupancies within the Village of Brightwaters are currently valid and up to date.

Inspections of commercial occupancies continue in the Village of Brightwaters with reinspections having also been conducted to ensure that all violations have since been removed.

Multiple attempts to inspect, have been made during the past weeks to accommodate the new management of Lulu's Lobster & Wing Shack, soon to be located at 91 Howell's Rd. The opening and occupancy IS NOT permitted until the approval of the Sprinkler System, Automatic Fire Alarm System and Emergency Lighting System have been tested and inspected.

There was no investigation of fire requested by the Bay Shore Fire Department during the past month.

**Open** Public Hearing on Local Law 2-2021 to amend Chapter 128- Zoning- Article XIII – The Powers of the Planning Board.

This local law will give the Planning Board authority to act as a binding Board on Commercial Applications only. Currently the Planning Board is an Advisory Board. A resolution would be passed for the applicant to cover the costs of the public hearings (ie: Legal, Stenographer, Engineer, etc). The Village would not be responsible financially. The local law needs to be redrafted for some minor revisions such as reconfiguring some of the wording and paragraph structure as well as some grammatical revisions.

Public Comment:

- Resident Ken Michaels: Will the planning board be publishing commercial property rules and regs that are not "subjective" and will be setting architectural standards for the commercial district? Attorney Charles Casolaro responded: We will not be publishing rules and regulations but will be setting some of an architectural standard based upon what the planning board approves/disapproves for the exterior look of a business in a district on some level.
- Resident Bob Fischer: Very happy to see the Planning Board acknowledged and expansion of powers. Concerned of the cost. Can they approve or deny residential subdivision? Attorney Charles Casolaro advised that no it is solely Commercial. Also, Trustee Fawcett requested the Attorney to changed the Law to start off with the Downtown Business District to start with and not to include all commercial properties in this law.
