## **Suffolk County Police Department:**

Unlicensed quads being driven around the Village. Very dangerous but if the Police try to chase them it could be dangerous for the kids driving them and get into an accident. They have to protect their safety as well. They can ticket them for Unregistered Motor Vehicle and if there were an instance they could get them for reckless driving. If they catch them the quad gets taken and impounded. If people see it call the police and better to know where they live for the police to identify them.

## Mayor's Report - Mayor Valdini:

- Gazebo Cocktail Fundraiser: This past Friday was a terrific event to raise funds for the restoration of the Gazebos at the top of the canal. There were about 300 people in attendance. Haven't done the exact tally yet but brought in about \$8,000 from the event and sold about 150 bricks to install at the gazebo. Some people have expressed interest in donating the services for this project such as the labor, carpentry, electric, plumbing. Once we get a better idea of the exact scope of work we can reach out again and advertise for donation requests. Looking to do another event like this possibly at Gilbert, Lakes, Walker Beach, Wohseepee.
- Camp: Ended this past week. Maria Dounelis did a fantastic job. This was the first year we did a whole day 9-2, in past years it's been 9-12. We had over 80 campers this year which is the most we've ever had. Parents were very grateful.
- Canal Bulkhead Project: Panel machine is being fixed in Canada so our finished panels will be in in a couple of weeks and will begin Phase 3. It's been a long wait to finish the final phase.

- 9-11 Tribute: It's the 20<sup>th</sup> Anniversary of September 11<sup>t.</sup> This year it falls on a Saturday and we are anticipating doing something at the top of the canal at about 8:30am but will have further details sent out in a flyer.
- Planning Board: Continuing to work on the rezoning of the Orinoco corridor. We hired a
  professional consultant to work with the Planning Board. There will be meetings in the near
  future on this involving the public and their input.
- Downtown: Last month completed the fence next to Sea Levels and they did the parking lot over. Mama Santinas will be starting shortly to redo their parking lot, extending store and leaving the tree up. Bob O'Shea spoke with their Architect and they have to revise the plan a bit and will be wrapping up their drawings.
- Veterans Brick: You can still purchase a Veterans Brick to be engraved on site. We will be doing another dedication ceremony this year for Veteran's Day.

### **Trustee Fawcett - Special Projects**

- Downtown Revitalization: Has work on the Downtown Revitalization from the start and is continuing to work on it. Looking to construct a Sidewalk and Handicap Ramp on Windsor Avenue heading South to Lawrence Dr. and possibly a pathway on Orinoco.
- Lakes: Still waiting on Solitude to get the Permit from DEC to treat the lilies at the lakes.
- Volleyball has been a huge success.

### **Public Comments:**

John Clark of Hiawatha Dr. – He put the petition in. From Bridgeway Blvd to Peters there is no stop sign at all. Between Ackerson and Pine Dr there is approximately 8 juvenile children there. During school the worst offender is the school bus. That's a long run to come through there with no stop signs. So many people are out and about walking into town. He really thinks they need one there. Would be curious to see how many "stop sign" tickets are issued in that area. Mayor asked Tony our Code Supervisor to get a 3-month report from the precinct on that.

Carmine Chiappetta of Pine Acres Blvd. – Not opposed to the stop sign. What are the rules on stop signs about putting them into place? What is the basis? Deputy Mayor Zepf is deferring that question to our Village Attorney Charlie Casolaro.

The Board will vote at the next Board of Trustees Meeting.
