Trustee Del Vecchio – Celebrations

 This Saturday is the Mother's Day Plant Sale at the top of the canal. We need volunteers and can use the junior volunteers. Also having a pop-up shop in the downtown area that same day. May 14th is the Village-wide Garage Sale. Make sure to get your permit. May 21st is the SOS run for postpartum depression. Memorial Day weekend ceremony on May 28th.

Mayor's Report – Mayor Valdini:

- The Community Safety Meeting was held on May 11th. About 50 people were in attendance. There was general information brought to the meeting. The Suffolk County Police Cope Officers, Senator Phil Boyle, Legislator Flotteron and the Village Board Members were there.
- Congratulations to Mario Fiore and his Scrap Cancer Fundraiser. The 30-yard dumpster was completely filled.
- Eagle Scout Projects have been completed. The erosion project at Nosrekca Lake and the New Message Board at Wohseepee Park.
- Walker Beach Handicap Bathrooms should be done in about a week. We have \$25,000 from the Town of Islip Community Block Grant to be reimbursed for materials.
- The Gazebo project is progressing.
- National Grid owes up curb to curb repair on all the roads they touched in our village.
- Easter Egg Hunt was a huge turnout. 2,500 eggs were gone in about 6 minutes.
- Memorial Day Weekend Ceremony is on May 28th at 10AM at the top of the canal.
- June 11th is the new event called the Brightwaters Open down at Gilbert Park. Fish ball contest, 9-hole putting course, music, food, drinks and much more.
- Illuminated sign code is now in effect. Every business will receive a letter that they must comply with the new code. We will give them some time to comply.
- Empty hardware store has no possible tenants currently.
- Bridges: Sometime in the near future we will have a meeting with the residents about the bridges. We are seriously considering turning those bridges into pedestrian only. We've had a FedEx Truck go over it and damage the bridge.
- Summer Program sold out in 5 minutes. We will have about 80 campers this year.
- The World Gym will be getting knocked down soon and will be a new storage facility, SafStor.
