# **BOARD OF TRUSTEES MEETING MINUTES – March 6, 2023**

## Mayor's Report – Mayor Valdini:

- History Area: Basement is unused space. Construction is being done at no cost to the village to make a space for the village's historical documents and files. The Village is forming a history group of which we've received many residents interested in participating in. They will maybe meet up once a month. In the near future we will be raising funds to preserve historical documents. In about two months the room should be ready. Resident John Clarke donated two books of all who served in the Town of Islip in WWII, Korean War and Vietnam War.
- Downtown revitalization on the Northeast corner sidewalk after Henley's should be complete in about 6 weeks.
- Adding lines to the tennis courts at Wohseepee Park for Pickle Ball. May start designating certain hours and days to play pickle ball.
- The Summer Program will still do the online registration but if we have over 85 campers registered it will then be put to a lottery. There were people who were turned away last year and this will be the fairest way to handle it.

## Trustee Dopsovic – Highway Department

- The Highway Department has just finished cleaning up around the lakes. Part of the problem with the lily pads growing is that the debris and leaves gather at the bottom of the lakes so we are staying on top of that by limit9ing what gets in there.
- They've been patching the service roads up, they seem to be in dire need of some assistance lately.
- Luckily there weren't any big snow storms this year. Winters almost over and we might get away unscathed.

• They are continuously patching up potholes and cleaning out the sewer drains every month. Please let the office know if anything is missed.

#### Trustee Fawcett – Special Projects

 Ongoing engagement with the DEC to modify our current permit adding the mechanical harvester. The Weedoo Boat Company will come in for 3 days to do the whole lakes, two times for the season. The cost is \$2,000 a day. The chemicals killed the lily pads but it was creating nitrogen which defeats the purpose. We are not contracting with Solitude and will move forward with Weedoo Boats and their mechanical harvester.

## Trustee Del Vecchio – Celebrations

- The Bay Shore Brightwaters St Patrick's Day Parade is this Saturday.
- Big thank you to Megan Quinn for organizing a fundraiser at the Brightwaters Inn to raise funds for playground equipment at Wohseepee Park. There will be no charge and no tickets but all the money raised from raffle baskets and donations will go towards the purchase of some toddler piece(s) of playground equipment. A flyer went out so save the date for Sunday, March 26<sup>th</sup> 2-5p at BWI.

## Deputy Mayor Zepf – Code Enforcement

- The four corners continue to be a problem with parking in no parking zones and crosswalks. Code is having a no tolerance approach and will be issuing tickets.
- Cars are still being targeted so lock your doors. Also, cars are speeding through the village so please slow down.
- Operation Vest Run and Plunge was a great success. Trustee Fawcett and Deputy Mayor Zepf participated in the event.
