At 8:00 pm, Mayor McDermott called the meeting to order followed by a salute to the flag and a moment of silence for our Armed Forces.

Trustee

Approval of the Minutes from the Board meetings of October 3, 2016 and October 17, 2016. Motion: Trustee Elliott Second: Trustee Sullivan Vote: 3 ayes 2 absent (Chiappetta, Whitwell) 0 nays

Suffolk County Police Department 3rd Precinct – No officer present.

Mayor's Report:

• This is a special month for the Village as 100 years ago this month this Village was incorporated. We had planned on celebrating with a soiree but it was canceled due to bad weather. We will reschedule in the spring.

- The Downtown revitalization is under way with new light posts, benches and trees.
- An update from the three hour working meeting held on October 17th:
 - Passed Local Law 6-2016 in favor of a stop signs in Hiawatha and Brooklyn intersection.
 - The Board voted in favor of going to bond for \$1.6M to repair 2,100 linear feet of bulk head on the canal as well as addressing the drainage concerns on Concourse West. We will also be addressing the water supply and installing conduit for the lighting.

DPW – Trustee Sullivan

• October has been a busy month with leaf season in full swing. Drains have been cleared, flowers watered and branches removed. Tree trimming is on-going with the removal of the dead branches in Village trees. Dead trees have also been identified and removed.

• When a resident requests that a tree be removed, we have an arborist assess the tree's health before committing to removing it.

• The planters surrounding the sycamore trees at the four corners are creating a health issue for the trees. We are having the situation evaluated.

• The lights are being put up by Manella for the Holiday tree at the head of the canal.

11/7/2016 - Board of Trustees Meeting

- The DPW buildings have had egress doors installed and upgrades to the flammable liquid storage areas. Electrical upgrades are still required.
- The debris pile at Gilbert Park has been completely removed. We were able to reclaim 2,000 SF of park land.
- Walker Beach boat basin: the gate and lock are being replaced with a new combination lock.
- The new DPW trucks are at the dealers and being prepared for delivery.
- An estimate of \$13k was received to repair the drainage issue on Peters Blvd. We will need another camera to review the exact problem. Moe quotes are required.
- The crew is being trained on chainsaw use and safety, as well as proper use of the chipper.

Code Enforcement – Trustee Chiappetta

- We are now at full staff. Our new officers are doing a nice job in assuming their roles and we are pleased with the progress of our new hires. Please be patient as they acclimate to their responsibilities and please do let us know if you have any issues and they will be addressed appropriately.
- Halloween night was fairly uneventful. Our Third Precinct officers showed their presence and kept foot traffic flowing. Thanks to our Code officers, Highway Department personnel, our friends at the Bay Shore-Brightwaters Library, SCPD. Special thanks to the Brightwaters Business Association for sponsoring the parade and dressing up the tennis court.
- We had a complaint about early garbage pickup on Howell's Road. The owner is cooperating so that it does not happen in the future.

Administration – Trustee Elliott

• I attended a PSEG meeting regarding high profile customers. They discussed a more aggressive tree trimming program to keep branches away from the wires. They received a FEMA grant for increasing the resiliency of their system, which is why you see new poles throughout the area. They are taller, sunk deeper in the ground and the cross bars on the top are shorter to be more hurricane resistant.

Fire Marshall's Report

As of this report, all permits for Public Assembly and Multiple Dwelling occupancies within the Village of Brightwaters are currently valid and up to date.

Commercial occupancy fire inspections continue in the Village of Brightwaters. Subsequent re-inspections having also been conducted to insure that all violations have since been removed. Currently, all commercial occupancies are being re-inspected to insure the required installation of CO Detection with the most recent installations at 160 Howells Rd.

There were no investigations of fire during the past month.

Progress continues at 59 Orinoco Dr. I am awaiting contact of building management regarding the scheduling for inspection, testing and acceptance of the Automatic Fire Sprinkler and Automatic Fire Alarm Systems. Progress of the process will be reported as it evolves.

LOCAL LAW NO. 7-2016

TITLE: "A Local Law to Amend Chapter 119 of the Code of the Inc. Village of Brightwaters – Vehicles and Traffic"

BE IT ENACTED BY THE BOARD OF TRUSTEES OF THE INC. VILLAGE OF BRIGHTWATERS AS FOLLOWS:

FIRST:Amendment to Section 119-4 ARTICLE IV – STOP INTERSECTIONS
§119-4 Stop Intersections Designated
This proposed section shall be added to 119-14, as follows:
(189) Linwood Court and Bay Way Avenue

SECOND: Separability.

If any section, sub-section, sentence, clause or phrase of this local law is for any reason held invalid or unconstitutional by decision of any court of competent jurisdiction, such decision shall not affect the validity of the remaining portions of this local law.

THIRD: Effective Date.

This act shall take effect immediately upon filing with the Secretary of State as provided by law.

Permission to contract with Michael Haberman Associates, Inc. to provide assessing and small claims/certiorari services. The rate is \$150/hour and will afford the Village the ability to exercise its function as an assessing unit.

Public Comment:

- Will there be ladders in the canal after the restoration? Yes.
- Do we know when PSEG will be removing the poles? No.
- Did the cost of the playground include the salaries of the DPW staff to install? No, the Village covered those costs because we needed skilled labor for the installation.
- Shed code will be reviewed at the working session and public session will be held at the December meeting.
- Trustee Whitwell is the liaison to the Revitalization Committee. The Chairman, Pat Fawcett, was informed that work was starting on the four corners.
- Paving of gas valves does not cause a gas leak. If a resident smells gas, they should call National Grid or the Fire Department as soon as possible.
- The roads paved this year were throughout the Village, not in one section. The list is on the web site.
- There are about 40 building permits issued throughout the year. Not all of them require an assessment change. There is always a lag when we use the Town's assessment roll. We will be able to have better control on what happens with our tax base.
