Bay Shore / Brightwaters Ambulance (BSBWA) Budget Discussion: President Jim Nelson, BOD Treasurer Robert Dean and BOD Secretary Dana DeQuartro of the BSBWA presented a request for an increase of 6% from the Village of Brightwaters to assist with in keeping ambulances on the road to continue to effectively answer calls for help throughout the community. One of the main reasons for the increase is low volunteers and more paid staff. Approximately \$600,000 of their 1.8 million-dollar budget will go towards having a paid staff on board. There will also be many other upgrades such as roll up doors, generator, etc. They are also implementing a paid billing program by 1/2021 which the village could decide at a later date if they want to participate in that.
