At 8:00 pm, Mayor McDermott called the meeting to order followed by a salute to the flag and a moment of silence for our Armed Forces.

Approval of the Minutes from the Board meeting of December 7, 2015 and December 14, 2015.

**Suffolk County Police Department 3<sup>rd</sup> Precinct** – P.O. Alicia Gomez was there to report that nothing noteworthy has occurred in the Village. There were reports of a loud bang but has yet to be identified as to its origin.

#### Mayor's Report:

- The Village's 100<sup>th</sup> anniversary of incorporation is this year. The Board would like to put together a committee to plan events to celebrate this momentous occasion. Please contact Village Hall if you are interested in volunteering
- Over the last 12 months, the Village has been the recipient of over \$265,000 in grants: \$56,000 for the archive grant, \$59,000 for Downtown Revitalization, \$100,000 towards a capital project from Senator Phil Boyles, \$50,000 for the new DPW building through Senator Boyle and a \$1,200 Justice Court grant. This is evidence of the hard work of the Board and the Clerk

#### **Highway Department – Trustee Whitwell**

- The DPW has been busy putting up the holiday decorations and then taking them down
- The trucks are prepared for snow
- The crew will be planting six new trees in Wohseepee Park
- Thanks to the Sagliocca family for donating greens to decorate the planters on the cascades

#### **Code Enforcement – Trustee Sullivan**

- There were 57 calls made to the SCPD. Activity has decreased as the temperatures decrease. Most of the calls were for alarms
- Graffiti continues to pop up in the Village. The business owners have been notified and asked to remove it ASAP. The graffiti was noticed on the door at the back of the post office, the auto store and on the side of the State Farm office
- Would like to commend the code officers in trying to identify where the loud bangs were coming from. Unfortunately, they were unsuccessful. They also chased a vagrant from Wohseepee Park, responded to transformer fire on Mohawk
- Our staff issued 59 summonses and 7 violations. There were 4 complaints including loud music, early trash pickup and a grey Nissan on Orinoco

#### **Administration – Trustee Elliott**

Document archiving preparation is going well. The project is on schedule

#### Fire Marshall Report:

As of this report, all permits for Public Assembly and Multiple Dwelling occupancies within the Village of Brightwaters are currently valid and up to date. Most recently, the "Public Assembly Permit" for *Sea Levels Restaurant* was processed and distributed.

As of this report, it is estimated that 90% of all commercial occupancies within the Village of Brightwaters have been inspected and evaluated for the implementation of the new law which will apply to all new & existing commercial buildings that have fuel burning appliances, systems or devices that emit Carbon Monoxide. Each tenant visited has signed an acceptance letter of the "new law". The conclusion of the preliminary inspection of the remaining commercial occupancies is anticipated within the next 30 days. In May of 2016, I will once again be visiting all location to insure the compliance with the "new law".

During the past month, there were no requests for investigations of fire from the Bay Shore Fire Department.

Mayor McDermott explained that the Village has been negotiating with several members of the Ambulance Corps to come up with an equitable amount that would continue to provide their excellent coverage in the Village. The Village has been paying \$60,000 a year for many years and it was insufficient to cover our share of the costs.

John Valdini questioned the 40% increase in the cost.

Jacqueline Fink, attorney for the Ambulance Corps, explained that the Village is 11% of the coverage area but at \$60,000 a year the Village was paying 4% of the costs. Brightwaters also represents 7% of the total calls to the Corps. The equivalent cost for Village residents is \$.098 per \$100 of Assessed Value whereas Bay Shore residents are paying \$.248 per \$100 of Assessed Value.

Laurie Hughes, Board member of the Corps, explained that they have a paramedic on every call. This is a higher level of care than what is provided by other services. The paramedics are paid by the Corps. They are seeking to upgrade their equipment to have transporters that can accommodate all shapes and sizes and they provide training for all Bay Shore and Brightwaters residents.

Joan Manahan asked about the contributions they receive from residents. Laurie Hughes explained that the funds received from contributions has diminished over the years.

#### Questions/Comments:

Stop signs are not the answer, speed humps would be better

- Why just one stop sign in each area? This will be confusing for the drivers headed the other way
- Request selective enforcement of the speed limit by SCPD
- · Possibly use speed signs to show people how fast they are travelling
- Reduce speed limit to 20 mph
- Business owner has been requesting a stop sign by the Faber Brothers entrance/exit

**Close** the **Public Hearing** on proposed Local Law 2-2016 to add additional stop signs on Orinoco Drive

Based on the discussion, the Board decided to table the adoption of this proposed Local Law.

**Open** the **Public Hearing on Local Law 1-2016** consecutive term limits for elected officials. This would limit the number of 2 year terms for each elected official to 4 consecutive 2 year terms, effective with the June 2016 election.

- Term limits are born out of having the same people in office for an extended period of time
- The voter has the right to vote people in and out of office
- The President of the United States has term limits

- This is such a small Village that term limits might end up with vacancies in offices if no one chooses to run
- The incumbent candidate has an advantage
- The issue should be put on a ballot
- The elected officials should be free to make the decisions without being on the ballot

#### **LOCAL LAW NO. 1-2016**

## TITLE: "A Local Law to Amend Chapter 19 of the Code of the Inc. Village of Brightwaters – Officers and Employees"

## BE IT ENACTED BY THE BOARD OF TRUSTEES OF THE INC. VILLAGE OF BRIGHTWATERS AS FOLLOWS:

#### FIRST: An addition to Chapter 19 of the Code.

#### ARTICLE III – TERM LIMTS – CONSECUTIVE TERMS OF OFFICE

§19-9. Mayor.

No person shall be elected to the office of Mayor for more than four (4) consecutive two (2) year terms.

**§19-10**. Board of Trustees.

No person shall be elected to the office of Trustee for more than four (4) consecutive two (2) year terms.

#### **§19-11.** Limitation of effect to two year terms

In computing the terms, only full two year terms are to be computed to set the limitations. §19-12. Applicability

This local law shall be applicable commencing in the Village election cycle immediately following its adoption.

## **SECOND**: **Separability.**

If any section, sub-section, sentence, clause or phrase of this local law is for any reason held invalid or unconstitutional by decision of any court of competent jurisdiction, such decision shall not affect the validity of the remaining portions of this local law.

#### THIRD: Effective Date.

This act shall take effect immediately upon filing with the Secretary of State as provided by law.

## Appoint LOCAL LAW NO. 1-2016

**TITLE:** "A Local Law to Amend Chapter 19 of the Code of the Inc. Village of Brightwaters – Officers and Employees"

BE IT ENACTED BY THE BOARD OF TRUSTEES OF THE INC. VILLAGE OF BRIGHTWATERS AS FOLLOWS:

### **FIRST:** An addition to Chapter 19 of the Code.

#### ARTICLE III - TERM LIMTS - CONSECUTIVE TERMS OF OFFICE

§19-9. Mayor.

No person shall be elected to the office of Mayor for more than four (4) consecutive two (2) year terms.

§19-10. Board of Trustees.

No person shall be elected to the office of Trustee for more than four (4) consecutive two (2) year terms.

**§19-11.** Limitation of effect to two year terms

In computing the terms, only full two year terms are to be computed to set the limitations.

#### §19-12. Applicability

This local law shall be applicable commencing in the Village election cycle immediately following its adoption.

### **SECOND**: Separability.

If any section, sub-section, sentence, clause or phrase of this local law is for any reason held invalid or unconstitutional by decision of any court of competent jurisdiction, such decision shall not affect the validity of the remaining portions of this local law.

#### THIRD: Effective Date.

This act shall take effect immediately upon filing with the Secretary of State as provided by law.

**Appoint** Brian Vogelfang as part time Parking Meter Attendant at a rate of \$12.00 per hour.
