- 29 trees have been removed in Wohseepee Park and there are several more to be removed
- Bond resolutions for canal repairs, road repaving and DPW equipment. Adopting a
  resolution does not mean the Village is entering into a debt agreement. The resolutions
  are foundations in case the Board decides to borrow the money for the projects. Agreed
  to \$1.5M for roads, \$1.6M for canal repair and \$250k for DPW equipment. Bond counsel
  will be notified to draft the resolutions

- Halloween: Business Association will sponsor the Ragamuffin parade from Chase bank to Wohseepee Park. A portable light will be erected in the Park and then moved to the fields at South Windsor and Montauk. There will be two additional lights in the area as well. Village will have two code enforcement officers and several DPW workers in the area.
- Conduct a public information session at the November work session regarding the downtown revitalization grant, invite the members of the committee as well as business owners in the four corners area and the Sunrise district
- Draft legislation for stop signs on Orinoco to slow traffic as it enters the four corners area
- FD Budget meeting: Trustee Elliott to attend
