- (b) only those records will be disposed of that do not have sufficient administrative, fiscal, legal, or historical value to merit retention beyond established legal minimum periods.

APPOINTMENT OF TEMPORARY-ACTING BUILDING INSPECTOR

WHEREAS, there are currently construction projects in the Village that are of an emergency nature that require immediate inspections;

WHEREAS, the current building inspector is currently under COVID related quarantine and unable to complete said emergency inspections; and, therefore,

BE IT RESOLVED, that by this Resolution the Board of Trustees authorizes the Mayor to hire Thomas Maher, a New York State licensed Building Inspector, as Temporary-Acting Building Inspector, to conduct said emergency inspections or perform any other function of Village Building Inspector, at a rate of compensation to be determined by the Mayor; and,

BE IT FURTHER RESOLVED, that Thomas Maher's authority to act as Temporary-Acting Village Building Inspector shall become effective upon passage of this Resolution.

WHEREFOR, this **RESOLUTION**, hereby adopted by vote of the Board of Trustees on January 19, 2021, shall be promptly recorded in the Office of the Village Clerk, and made part of the public record.

Topics for Discussion:

 Discussion of Proposed Planning Board Powers and revised Legislation: The Village would like the Planning Board to have a focus on the Businesses in the Downtown District and have a designation with only Commercial Properties. Mayor will be calling for a Public Hearing to be held at the March Board of Trustees Meeting. Planning Board is also working on the rezoning of Orinoco Drive.

- Concourse E. Bulkhead repair: The Bid Opening will be held on January 27th and the Village will have more of an idea what the cost will look like. 11 contractors picked up the bid packets. There are different options of the work to be performed in the bid packets. Bid results will be discussed at the next Board of Trustees Meeting on February 1st.
- 24 Hiawatha Drive: The Village will be moving forward and taking the necessary steps to Authorize the Village Building Inspector to have Discretionary Authority to Condemn and Demolish the vacant structure at 24 Hiawatha.
- National Grid: Our Village Attorney was contacted by National Grid's Attorney about the
 possibility of purchasing the Village Road to use mainly for storage and they will be
 responsible to maintain and clean up the road. The Village Attorney will look into getting
 an appraisal of the road.
- Deputy Clerk Carol Posimato is retiring and will be with us until the end of the fiscal year. We will be bringing in another office worker to start training and will be shifting responsibilities in the office.
- An informational flyer will be sent out to all residents before the next Board Meeting.
