Village of Brightwaters will hold a public hearing, under the authority of a Certificate of Necessity issued pursuant to section 20(4) of the Municipal Home Rule law on Monday, June 1, 2009 at 8:00 p.m. at Village Hall, 40 Seneca Drive, Brightwaters, NY to consider the adoption of proposed local laws #2 - 6 of 2009 to amend section 61-4 of the Brightwaters Code to redefine "Start of Construction", to amend section 61-6 of the Brightwaters Code to update the Flood Zone Map Number, to amend section 61-7 of the Brightwaters Code to update Flood Insurance revisions date, to amend section 61-16C(1) of the Brightwaters Code to regulate utility placements in flood zone structures and to amend section 61-18 of the Brightwaters Code to update the definition of structures in Coastal High Hazard Areas.

All interested persons are welcome and will be given an opportunity to be heard.

The village attorney, Jack Finnerty explains – these amendments to the code are required in order to conform to the 2009 State government requirements. This is a requirement in order for homeowners to get flood insurance.

The Mayor signed the Certificate of Necessity for each law which allows for a vote on the same night as the public hearing.

The Mayor opened the public hearing for any comments and/or questions, there being none, the Mayor moved to close public hearing and Tr. Charles Fischer seconded and all approved 4/0.

Tr. Charles Fischer moved to approve local laws #2-6 of the year 2009 and Tr. Belford seconded and all approved 4/0.

Resolution authorizing village to enter into a contingency fee contract

WHEREAS, the Village of Brightwaters is located in the Southwest Sewer District and the infrastructure of the Sewer District is located underneath all of the Village's roads, and

WHEREAS, various other municipalities have been compensated by the insurance companies of the sewer contractors for damage to their roads caused by improper sewer construction work by such contractors, and

WHEREAS, the law firm of Carman, Callahan & Ingham of Farmingdale, New York represented the municipalities which were compensated for such damage, and on a contingent fee basis, and

WHEREAS, said law firm has inspected the Village's roads and believes that the Village has a viable cause of action against the Southwest Sewer District contractors, and has offered the Village of Brightwaters a contingent fee contract to pursue such damages,

NOW, be it therefore

RESOLVED, that the Mayor of the Village of Brightwaters shall be, and hereby is, authorized to enter into a contingency fee contract with Carman, Callahan & Ingham Esqs. to pursue such legal action, and the Village is hereby authorized to commence such suit against any and all entities allegedly responsible for the damage to the Village roads, in the sound discretion of the Mayor, upon advice from Carman, Callahan & Ingham Esqs.

The village attorney, Jack Finnerty, explains that this firm is famous for going after the Southwest Sewer District and has won \$17 million. It's a continuing tort. The Mayor stated that he and Jack will meet with the firm on Wednesday, 6/3@4p.m.

Tr. Charles Fischer moves to approve resolution and Tr. Belford seconded and all approved 4/0.

2009 Tree Planting Bid

Tr. Charles Fischer awarded the tree planting bid to Louis Barbato Landscaping for a total bid of \$3260 and Tr. Belford seconded and all approved 4/0.
