At 8:04 pm, Mayor McNulty called the meeting to order followed by a salute to the flag.

Oath of Office

Village Clerk Christine O'Shea administered the oath of office to Trustee John J. Riordan and Trustee Denise Gibson to discharge the duties of Trustees for a term of two years.

After the Mayor and Trustees were sworn in, a motion to approve the minutes of 6/4/12 as written was offered by Tr. Riordan, seconded by Tr. Fischer and all approved 5/0.

Trustee Fischer read his report for this meeting –

Matt Brennan, Fire Marshal, has processed the public assembly permits within the village as well as fire inspections. The BSFD had not requested his help this past month for fire investigations.

Tr. Fischer also brought up Robert S. Gilbert Park. One day last week the highway crew had counted 18 dog feces that were not cleaned up. This could be a health problem. Everyone that brings their dog to the park must clean up after their dog; the village even supplies the bags if you don't bring one with you. The code officers are instructed to patrol the park in the morning.

Highway Dept.

Tr. Riordan mentioned that George Peterson has retired after 20 years of service. His last day on the job was Friday, June 22, 2012. The Board is working to identify a new Highway foreman. Charles Fischer is the interim Highway foreman right now.

Tr. Riordan read his report for this meeting –

The seaweed fence was installed at Walker Beach. This helps in keeping the swim area clean and clear.

The erratic weather we've had over the last week has caused many trees to lose large limbs and a few to come down resulting in a lot of debris to be cleaned up for the village.

Clogged drains were cleaned out throughout the village as well.

The DPW set up for movie night and prepped the cabin and Wohseepee Park for the opening of Day Camp which will begin Thursday, July 5th.

Replaced damaged water spigots at the canal.

Regular village maintenance such as trimming and water of plants and flowers done throughout.

The Southwest Sewer District has completed the installation of equipment portion of their project. We are continuing to work with them until the project is completed.

RESOLVED that J. P. Morgan Chase Bank be and hereby is designated as the depository for the village funds in the General, Payroll, Trust, Restoration and all other funds, said bank to pledge suitable and sufficient collateral at all times for the protection of said funds and that the funds in these various accounts be made available upon the signature of any two officers.

BE IT FURTHER RESOLVED that any two of the following officers of the municipality, to wit: Joseph A. McNulty, Mayor, John J. Riordan, Trustee, or Christine O'Shea, Village Clerk Treasurer alone, with the approval of the foregoing, are hereby authorized to make arrangements to borrow money to obtain credit for this municipality from the JPMorgan Chase Bank or such bank as may seem advisable to make and deliver notes, drafts, acceptances, advances, agreements and any other obligations of this municipality therefore in form satisfactory to said bank and to manage and transact bank matters or other business of any kind whatsoever with the bank or its officers. Also, the treasurer is empowered to invest idle fund monies of the village at her discretion and in the best interest of the village, with the approval of the Mayor.

RESOLVED that idle fund monies be invested in CLA\$\$ from the General Fund, Restoration B.I.G. account and sufficient collateral be pledged for the protection of said funds.

RESOLVED that the village board meetings be held on the first Monday of each month excepting those falling on a holiday and then the meeting will be held on the day following the holiday. The village is authorized to notify by postings, newsletters or the news media of such meeting schedule.

RESOLVED that certain recurring charges such as postage, public utility bills, payroll salaries, petty cash and other usual expenses be paid in advance of audit of claims.

RESOLVED that the Board of Trustees shall approve reimbursement to officers and employees of the village who use their personal automobiles while performing their official duties on behalf of the village at a rate of 55.5 cents per mile.

RESOLVED that the Capitalization Policy will be recorded on capital assets (.2 equipment) which generally have a cost of \$1,000 or more at the date of acquisition and have an expected useful life of more than one year
