At 8:07 pm, Mayor McNulty called the meeting to order followed by a salute to the flag. After the Pledge of Allegiance, a motion to approve the minutes of 10/3/11 and 10/18/11 as written was offered by Tr. Charles Fischer, seconded by Tr. Robert Fischer and they were approved 5/0.

#### Suffolk County Police Dept. Third Precinct

Police officer Peter Scheuere was present at this meeting. He reported that there was one grand larceny, one criminal mischief, three petty larcenies and two harassment charges in the village last month.

## Resolution for Health Benefits for Elected Officials

The Mayor read the following resolution aloud......

#### RESOLUTION

WHEREAS, the Board of Trustees voted on December 19, 1996 to extend health insurance benefits to all Trustees and the Mayor, at the expense of the Village, but only while in such elective office, and further extended to any ex-Trustee or ex-Mayor who has served for six (6) years or more the same coverage he or she received while in office but at half-price, the other half to be paid by the Village, and

WHEREAS, the Board of Trustees voted on April 25, 2001 to extend health insurance benefits to all sitting elected officials, and their families, at the expense of the Village, for the life of such official, if he or she has served at least ten (10) consecutive years as an elected official of the Village, and

WHEREAS, the Mayor, four Trustees and the Village Justice constitute the elected officials of the Village, and

WHEREAS, the Board of Trustees deems it appropriate to review the entire health insurance benefit program for the Board of Trustees at Village expense, in this time of economic downturn and spiraling health care costs.

NOW, be it therefore

RESOLVED, that effective as of January 1, 2012, no Mayor or Trustee then in office, or future Mayor or Trustee, shall receive any health insurance benefits, while in office or in the future, at the expense of the Village, and it is hereby further

RESOLVED, that effective as of January 1, 2012, no Mayor or Trustee, formerly in office, shall receive any health benefits, at the expense of the Village, and it is hereby further

RESOLVED, that effective as of January 1, 2012, any Mayor or Trustee then in office shall be entitled to continue to receive health insurance through the Village, but at said official's sole cost, as long as required by COBRA, and may continue same after the expiration of COBRA, at said official's sole cost but only while still in an elected position of the Village, and it is hereby further

#### 11/7/11 - Board of Trustees Meeting

RESOLVED, that effective as of July 1, 2014, no Village Justice then in office, or future Village Justice, shall receive any health insurance benefits, while in office or in the future, at the expense of the Village, and it is hereby further

RESOLVED, that effective as of July 1, 2014, any Village Justice then in office shall be entitled to continue to receive health insurance through the Village, but at said Justice's sole cost, as long as required by COBRA, and may continue same after the expiration of COBRA, at said Justice's sole cost but only while still a Village Justice.

Tr. Bob Fischer moved to approve aforementioned resolution, Tr. Belford seconded and all approved 5/0.
