- We are starting to have more conversations about putting in some new playground equipment at Wohseepee Park. Not a lot for the toddlers to play on at the moment. Resident Megan Quinn is helping with this project. Looking to raise money towards a piece(s) of playground equipment for Wohseepee Park.

### Deputy Mayor Zepf – Code Enforcement

- Code is still trying to manage the four corners and to keep it as safe as possible.
- Also, with the cold weather people are down by the lakes and we need to control that area.

<u>Marco Homes Application</u> - Mark Sagliocca of Marco Homes is seeking relief from Section 128-16 of the Brightwaters Village Code which limits a building in the Business District to one story. The applicant is proposing a two-story building. A decision will be rendered at the next Board of Trustees Meeting on February 6, 2023.

### **Public Comment:**

- Mark Sagliocca states the luxury apartments will compliment the Business District with the much-needed foot traffic that will help to support the businesses in town.
- Trustee Fawcett thanked Mr. Sagliocca for taking the recommendations from the Board and that it far exceeds what he envisioned for that spot.
- Carmine Chiapetta of Pine Acres Blvd. said its been vacant for several years showing concern with the apartments.
- Resident Michael Dunn is in favor of the application.
- Ray Samson of 70 Bay Way is in favor of the application.
- Joseph McDermott of Potter Blvd. asked why this was not set up as a public hearing?
- Jean Marie Buffet of N Windsor Avenue fully supports the application.
- Anne Shierant of Potter Blvd. was concerned of the traffic issues and asked if a traffic study could be conducted.
