Adoption Of The State of New York Deferred Compensation Plan

WHEREAS, the Inc. Village of Brightwaters is a local public employer eligible to adopt the Plan pursuant to Section 5 of the State Finance Law* and

WHEREAS, the Inc. Village of Brightwaters Board of Trustees has reviewed the Plan established in accordance with Section 457 of the Internal Revenue Code and Section 5 of the State Finance Law of the State of New York; and

WHEREAS, the purpose of the Plan is to encourage employees to make and continue careers with the Inc. Village of Brightwaters by providing eligible employees with a convenient and tax-favored method of saving on a regular and long-term basis and thereby provide for their retirement;
