# Mayor's Report - Mayor Valdini:

- **Emails** Mayor urged everyone to sign up to receive emails from the Village as especially now this is our main method of contacting people with important updates.
- Summer Camp We do plan on having summer camp and will be taking registrations after May 15<sup>th</sup>.
- Walker Beach We are in the process of trying to get our lifeguards certified and we will open up Walker Beach Memorial Day weekend and will be open daily throughout the season.
- **Village Election** Pushed back to September 15<sup>th</sup>. We are still waiting for guidance from NYS about when the petition process can be started.
- Summer Activities The Mayor and Trustee Del Vecchio will be sitting down with resident volunteers, Brooke Pitta and Bernadette Whitwell to go over which events will happen this summer. It is a wait and see for the next couple of weeks as we will continue to get updates from Suffolk County regarding the reopening of NY.
- Veterans Walkway We've sold over 200 bricks and plan on doing the dedication on July 4.
- **Construction** Continue to get your permit applications in so when things loosen up we can start to process them.

## **Trustee Fawcett - Special Projects:**

- **Digitizing Permit Applications** We are looking at everything we do and are trying to become more of a touchless Village and more online. We are working with Adobe Government for fillable applications.
- **Social Distancing** A lot of people are walking now. Please keep practicing social distancing so that we can continue to keep open our parks.
- Reimagine Gilbert Park. Wants to get feedback on what we can do down there to make it more accessible to our residents. Mayor added that we are one day away from closing Gilbert Park down due to residents not keeping their dogs on a leash.

# RESOLUTION 3-2020 PENALTY FOR UNLICENSED LANDSCAPERS

**WHEREAS,** in accordance with local law 3-2020 requiring all landscapers operating within the Village of Brightwaters to obtain a License from the Village Clerk before commencing any landscaping work and to ensure compliance with this local law, the Board of Trustees does hereby **RESOLVE**:

**NOW, THEREFORE, BE IT RESOLVED**, that any individual Landscaper or Landscaping company operating within the Village of Brightwaters without a License shall be fined One Hundred (\$100.00) dollars.

**BE IT FURTHER RESOLVED**, this penalty schedule shall become effective immediately upon adoption of this Resolution.

**WHEREFOR**, this **RESOLUTION**, is hereby adopted by unanimous vote on May 4, 2020, before a duly constituted meeting of the Board of Trustees, shall be promptly recorded in the Office of the Village Clerk, and made part of the public record.
