At 7:30 pm, Deputy Mayor Zepf called the meeting to order followed by a salute to the flag and a moment of silence for those who served our country and passed.

Approve previous Board Minutes from February 5, 2024.

<u>Suffolk County Police Department:</u> - Suffolk County Police Officer Fisher was present for the meeting. Deputy Mayor Zepf pointed out that on Woodland / Union there has been alleged drug activity and the police were called 2-3 separate times on this. Trustee Dopsovic mentioned that just south of Union there is one house and service road. They are parking in service road and cutting through the grass to cut through to Union. The Officer will look into it.

Scout John Brownyard from Troop #153 based presented his Eagle Scout Project to the Board. He would like to spruce up the area at Wohseepee Cabin to include a 8x4 planter. He will fundraise in May and in June/July it will get built. Trustee Del Vecchio advised to get in touch with Jennifer Barlett and Anne Shierant from the Beautification Society to work out the details.

Trustee Del Vecchio – Celebrations:

• Saturday March 30th is the Easter Egg Hunt at Wohseepee Park sponsored by the Village and the Lions Club. The age groups will be separated.

<u>Trustee Zepf – Code Enforcement:</u>

- This month the Village had 4 Building Permits issued and 7 Plumbing Permits issued. 3
 applicants will need to go before the Zoning Board of Appeals to request approval for a
 variance. The Town of is working on renewing our Inter-Municipal Agreement and contract
 to continue shared services with their Fire Marshall which has been very successful.
- We are still a little short staffed with Code Enforcement but they are great about covering shifts. They've been all over the Woodland / Union drug activity in contacting the police on that issue. Working to clean up the four corners, parking in front of the dance studio has been worse than he's ever seen.

Trustee Dopsovic – Highway Department:

• The past month we've had to plow and salt the roads in turn creating more pot holes. The DPW is working on filling them in but if you see one that is missed, please call the Village Office. The storms keep coming through and we've been going around cleaning drains and some of the are clogging underground. Time has been spent on cleaning up the sweet gum trees and out of the drains. The spiked balls are everywhere. We ask our neighbors to give us a little assistance as well. The Village is looking into contacting an arborist on a chemical to inject to treat and alleviate some of the balls on the tree.

Trustee Fawcett - Special Projects:

- Trying to figure out how to manage the water on Concourse E & W. Looking into putting in 1-2 check valves to help. We have situations not in a rain event when the tide is high and flooding over the bulkhead. There's no one solution but are working on ways to manage it better to get it back to normal faster.
- Working on the erosion issues near the lakes. Trustee Fawcett met with Senator Weiks in Albany and she advise him to look into the fund for Clean Water Act. He is looking to see if the erosion at our lakes and beaches fall within the guidelines for this application. He's researched landscape mats to try to slow down the run off in the street and would like to start at Lakeview Ave W. Also, looking into using fill to extend the footage from the thruway. There are a couple of spots that were like 3 feet from the water's edge and that will continue to erode.
- Better ways to make our parks more user friendly for our seniors. All of our parks have been getting tremendous use over the past couple of years but there is not a lot of shade for our seniors.
- Trustee Fawcett has a special needs son and would like to see our code allow for caregivers of special needs or elders to live in the house. Currently the code doesn't allow for that.
- It is budget season and we are in a good spot. Trustee Fawcett admitted to being completely opposed to breaking the tax cap. We need to tighten our belts for a couple of years. One of the bigger budget issues we have is that we get CHIPS money to pave our roads and they have stopped allowing local governments to submit bond payments for CHIPS reimbursement. We will have to pave the roads to be reimbursed and we have two years left of bond payments.
