At 7:35 pm, Mayor McDermott called the meeting to order followed by a salute to the flag.

 Adopt Resolution 2-2016 Road Reconstruction Policy indicating the amount of time between when a road is paved and when a utility company can excavate said road, except for emergencies.

WHEREAS, the Mayor and the Board of Trustees have determined that for the purpose of maintaining the integrity and durability of reconstructed and newly paved roads within the Village, and to better manage costs and expenses associated with the Village's established road program, and in furtherance of those legitimate governmental objectives, does hereby **RESOLVE**:

RESOLVED, that it shall be the policy of the Village of Brightwaters that any utility company seeking to install its utilities in or on a newly paved Village road, where the fitting of that utility company's equipment would require underground construction and installation, must wait for a period of time of not less than sixty (60) months from completion of the paving of the road before utility work can commence.

BE IT FURTHER RESOLVED, and in the normal course of village business, a utility company that seeks to work on a Village road must first obtain permission from the Building Department, with a Building Department sign-off affirming a specific road's eligibility for utility installation.

WHEREFOR, this **RESOLUTION**, hereby adopted by vote of the Board of Trustees on February 22, 2016, shall be promptly recorded in the Office of the Village Clerk, and made part of the public record.
