Mayor's Report:

- Still in the process of repairing some of the lawns that were damaged during the snow storm. Please call Village Hall if your lawn was not repaired
- The bid for the DPW building came in with a low bid of \$509,000 with a high bid
 of in the range of \$809,000. We are still in the process of reviewing the bids to
 determine how we would pay for it or if they are acceptable.

<u>Code Enforcement – Trustee Sullivan</u>

- There were 55 calls to the SCPD, 11 domestic, wires on the roadway, teens gathering, men fighting in roadway
- The Village issued 43 summonses and 5 violations notices, three of which have been resolved. They have 10 days to comply before an appearance ticket is issues. There were 11 complaints taken and resolved by the staff. There was a car that turned on to the rail road track at Union and Wohseepee. Building Inspector has followed up on other violations. Please lock windows and doors. Remember to change the batteries in your smoke detectors and carbon monoxide detectors.

Fire Marshall's Report

As of this report, all permits for Public Assembly and Multiple Dwelling occupancies within the Village of Brightwaters are currently valid and up to date.

The majority of commercial occupancies within the Village of Brightwaters have been inspected and evaluated for the implementation of the new law as required regarding Carbon Monoxide detection. Several attempts and multiple calls to 3 remaining occupancies have been made and will continue to be made to visit, evaluate and implement the new law. Each tenant visited has signed an acceptance letter of the "new law". As was previously mentioned, in May, I will once again be visiting all location to insure the compliance with the "new law".

I am now in receipt of "blue prints" pertaining to the new construction of a *Self-Storage Facility* to be located on Orinoco Dr. In the coming weeks, I will be reviewing the plans as related to the installation of an Automatic Sprinkler & Automatic Fire Alarm Systems. I will be communicating and coordinating with Building Inspector Robert O'Shea as the process progresses.

During the past month, there were no request for investigations of fire from the Bay Shore Fire Department.

Adopt Local Law 2-2016:

TITLE: "A Local Law to Amend Chapter 119 of the Code of the Inc. Village of Brightwaters – Vehicles and Traffic"

BE IT ENACTED BY THE BOARD OF TRUSTEES OF THE INC. VILLAGE OF BRIGHTWATERS AS FOLLOWS:

<u>FIRST</u>: Amendment to Section 119-4 ARTICLE IV – STOP INTERSECTIONS

§119-4 Stop Intersections Designated

This proposed section shall be added to 119-14, as follows:

(186) Orinoco Drive and Richland Boulevard. Stop for traffic eastbound on Richland Boulevard. Stop for traffic westbound on Richland Boulevard.

SECOND: Separability.

If any section, sub-section, sentence, clause or phrase of this local law is for any reason held invalid or unconstitutional by decision of any court of competent jurisdiction, such decision shall not affect the validity of the remaining portions of this local law.

THIRD: Effective Date.

This act shall take effect immediately upon filing with the Secretary of State as provided by law.
