INC. VILLAGE OF BRIGHTWATERS SUFFOLK COUNTY, NEW YORK FEBRUARY 27, 2023

WHEREAS, pursuant to New York State Village Law; New York State Municipal Law and the Village Code, the Board of Trustees hereby **RESOLVES,** as follows:

WHEREAS, on September 6, 2022, the Board of Trustees conducted a public hearing on the site-plan application of Brightwaters Racquet & Spa, INC, (SafeStor), at 225 Howells Road, for the construction of a self-storage facility within the Sunrise Business District to a height of three (3) stories, where the code allows only one (1) story; and,

WHEREAS, the Village Board as Lead Agency has caused to be prepared the attached Short Environmental assessment Form (EAF) to evaluate potential significant adverse impacts associated with the proposed action, and has reviewed the aforesaid Short EAF; and,

WHEREAS, the Board of Trustees approved the application for a height of three

(3) stories; and,

WHEREAS, the applicant's counsel notified the Village Attorney that in 1984 the then Board of Trustees of Brightwaters imposed covenants and restrictions relating to the use of 225 Howells Road as the Brightwaters Racquet & Spa, INC; and,

WHEREAS, that Declaration of Covenants and Restrictions were recorded on September 20, 1984 in Liber 9644 Cp 575; and,

WHEREAS, on January 26, 2022 and then again on February 23, 2022, the applicant appeared before the Zoning Board of Appeals having been granted specific relief that included parking relief, accessory structure placement relief and relief for the size and width and placement of two driveways for ingress and egress, all to allow for the construction of a storage facility 225 Howells Road; and,

WHEREAS, pursuant to the granted relief from the Zoning Board of Appeals, the imposed covenants and restrictions are no longer of any force and effect, as the nature and use of the real property will now change from a racquet ball club and workout gym to a storage facility; and,

NOW THEREFORE, BE IT RESOLVED, that the Village Board of Trustees the hereby resolves, as follows:

RESOLVED, that the Village Board of the Village of Brightwaters pursuant to the State Environmental Quality Review Act (SEQRA) is declared the Lead Agency for the proposed action and hereby proposes to adopt its findings; and

BE IT FURTHER RESOLVED, that the Village Board, as lead agency for the proposed action, pursuant to 6 NYCRR Part 617, hereby determines that the proposed action is an Unlisted Action; and

BE IT FURTHER RESOLVED, that the Declaration of Covenants and Restrictions imposed by the Board of Trustees against the property known as 225 Howells

Road, Brightwaters, New York recorded on September 20, 1984 in Liber 9644 Cp575 are hereby declared a nullity of no force and effect and by this Resolution the Board of Trustee consents to their removal from any future deed of conveyance; and

BE IT FURTHER RESOLVED, this Resolution may be recorded in the Office of the Suffolk County Clerk and made part of the public record.
