#### 3/5/12 - Board of Trustees Meeting

The roof on the landscape building has been repaired. This was funded by FEMA and our insurance after the March 2010 Nor'easter damaged the building.

Gilbert Park will be sporting a new look. We started a renovation on the east end. Removed damaged bushes and trees in preparation for replanting new items.

Cold patch was done throughout the village.

Pedestrian crossing signs keep disappearing. We had to order 2 more.

At the end of Concourse West by the bay, erosion was restored with fill, and new sea grass is in the process of being planted.

Upgraded some of the stop signs throughout the Village.

Repaired some of the drainage boxes within the Village.

We planted ornamental grasses on Duck Island.

Upgraded the child swings of our swing sets.

Work started on the Breakwater repair at Walker Park.

#### **Lakes and Parks**

Tr. Cox mentioned the playground equipment that is still roped off at Wohseepee Park should be taken care of by April. At the beach the motorcycle rocker toy will be replaced with a dolphin rocker toy. The old one is not fixable. Upcoming events will be the plant sale, family beach nights and movie night.
