At 8:04 pm, Mayor McNulty called the meeting to order followed by a salute to the flag. After the Pledge of Allegiance, a motion to approve the minutes of 11/7/11 as written was offered by Tr. Charles Fischer, seconded by Tr. Robert Fischer and they were approved 5/0.

Suffolk County Police Dept. Third Precinct

Police officer Peter Scheuere was present at this meeting. He reported that there were 51 calls of service and 31 of them were alarms. There were two petit larcenies.

Trustee Reports

Code Enforcement

Tr. Bob Fischer read his November report for this meeting......... Summons served 18, fines collected \$700., complaints prepared 5, building permits issued 2 for \$1050., CO inspections 3/\$150., dumpsters 3/\$75., and fence permits 1/\$25., and business permits 1/\$15. Tr. Fischer also referenced the Fire Marshal, Matt Brennan's letter, stating that all multiple dwelling and public assembly permits are valid and up to date. Fire inspection activity continues weekly throughout the village with periodic re-inspections of all commercial properties insuring code compliance. Holiday inspections will also be conducted to insure all issues relevant to life and fire safety are maintained at occupancies that experience higher than normal activity.

Administration

Tr. Belford moved to approve abstract report#3575 for accounts payable vouchers totaling \$255,482.86 and Tr. Charles Fischer seconded and all approved 5/0.

Highway Department

Tr. Charles Fischer read his report for this meeting... Leaf clean up and general fall clean up was done throughout the village and will continue as needed.

Barbato Landscaping planted 65 trees throughout the village. Many of these plantings were taken from resident requests but some were also due to downed trees from Hurricane Irene.

The vac-all truck was in for two days cleaning all drains in the village.

A new drain was installed at the northeast corner of Peters Blvd & Seneca Drive.

A damaged drain at 33 Concourse West was repaired by the DPW.

Christmas lights were installed for the annual tree lighting ceremony. All other decorations were also put in place.

The regular maintenance of cold patch work and sign replacement was done as needed.

Village of Brightwaters enter into contract with the Bay Shore Fire District and agrees to pay the Bay Shore Fire District the amount of \$184,183.95 on or before the 1st day of September, 2011, and also agrees to reimburse promptly the District for the cost of insurance required under the Volunteer Firemen's Benefit Law, Section 30, incurred with respect to protecting the Inc. Village of Brightwaters which cost is estimated to be \$25,734.28 based upon current premiums as based upon village population.

Contract to begin January 1, 2012 and shall continue to and include December 31, 2012.
