After that a motion to approve the minutes of November 2, 2009 as written was offered by Tr. Charles Fischer, seconded by Tr. Belford and all approved 5/0.

Suffolk County Police Dept. Third Precinct

No Police officer was present at this meeting and the incident report for the month of November had been received and distributed to the board.

Trustee Reports

<u>Highway Dept.</u>

Tr. Bob Fischer read his report for this meeting.....

All the sprinkler systems in the village have been blown-out and winterized.

A new drain was installed at 521 Ackerson Boulevard and at the northwest corner of Iroquois Drive and Peters Boulevard.

55 new trees were planted by Barbato Landscaping.

Walker Beach was winterized.

Graffiti was removed from road signs around the village.

Stop bars were painted throughout village.

Lights and decorations were put up for the Christmas Tree Lighting Ceremony.

We are in our last week of unlimited landscape pick up. So far all has gone relatively smoothly.

Tr. Charles Fischer added that resident Peter Coughlin had run into some pretty nasty incidents at the crosswalks at the four corners of our business section. Violators that park their vehicles in crosswalks will be ticketed and he emphasizes it is illegal to park there, so don't.

Lakes and Parks

Tr. Belford wanted to thank Judy Sallie for all her hard work in organizing the "Photos with Santa" on Saturday, Nov. 28. Over 300 families had shown up with children and pets. After the photos, Santa was escorted to the head of the harbor by the BSFD for the annual tree lighting. She also thanked Tr. Valdini for getting the cookies. And she also thanked the "Jans" for getting the Elf to help us. Don't forget there will be Christmas Caroling i/f/o deli on Christmas Eve at 5pm.

The mayor wanted to add a thank you to Chris Bilello for the Christmas music at the tree lighting.

Administration

Tr. Charles Fischer moved to approve Abstract Report #3293 for accounts payable vouchers totaling \$144,915.79 - The primary drivers was the garbage collection at \$31,000., tree trimming/removal \$10,000., medical insurance \$17,000., NYS Retirement ER share at \$40,000., street repairs at \$20,000., - other wise business is as usual and Tr. Belford seconded and abstract was approved for payment 5/0.

Security

Tr. Valdini mentioned that a fence on the north side of village had no permit and he had spoken to homeowner and he did cut fence back and put bushes in front of fence. He also mentioned that he heard from Mr. Perry and he said that it is very dark at the cascades. Lights had been repaired and it is bright there now. The stop sign at Mohawk and Potter have been put up. Bud Ruter requested to have Newsday stop throwing the free papers at front door. He received complaints on Mennella starting too early in the morning and now the code officer starts earlier to field similar complaints. Also, dog barking calls were addressed. The real estate signs are okay now. The code officers are issuing parking wrong way on street tickets as well as parking in crosswalks. The nail salon with the illegal signs is due in court on 12/9. Boats stored on property need storage permit approval. And don't forget to LOCK your doors on your house and your cars.

RESOLUTION to amend section 128-3 of the Code of the Village of Brightwaters to define a Wind Power Generating Facility.

Be it enacted by the Board of Trustees of the Village of Brightwaters that the above section of the Code of the Village of Brightwaters shall be, and hereby is, amended as follows:

128-3. Definitions.

WIND POWER GENERATING FACILITY – A facility at which wind is converted to another form of energy for distribution to the property upon which it is located, or to others.

<u>RESOLUTION</u> to create section 128-28.1 of the Code of the Village of Brightwaters to Prohibit Wind Power Generating Facilities.

Be it enacted by the Board of Trustees of the Village of Brightwaters that the above section of the Code of the Village of Brightwaters shall be, and hereby is, created as follows:

128-28.1. Wind Power Generating Facilities prohibited.

Wind Power Generating Facilities are prohibited on all parcels in the Village.

EXPLANATION: Matter underscored is new; matter in the brackets is old law to be omitted.

Tr. Charles Fischer read aloud the above resolutions and moved for a public hearing to be held next month and Tr. Belford seconded and all approved 5/0.
