- PERMITTED WORK DAYS/HOURS: Monday–Friday 8AM-6PM & Saturday 9AM-5PM (**WORK PROHIBITED Sundays & Federal Holidays**)
- Parking is prohibited on the lake side of the street at the Lakes and the bulkhead side of Concourse East & West
- All grass and landscape debris **MUST** be taken with you after the service.
- **DRIVING COMMERCIAL LANDSCAPING VEHICLES OVER BRIDGES AT THE LAKES IS PROHIBITED AND WILL RESULT IN THE LICENSE BEING REVOKED**

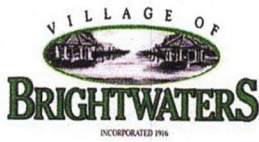

## **LANDSCAPER'S LICENSE—2024**

### **RESTRICTIONS - *subject to the issuance of a appearance ticket, fine, and/or license being revoked***

- No gardener, landscaper or any person performing a gardening or landscaping function shall cause or permit anyone to blow, rake or otherwise cause or permit leaves, grass or other debris to be deposited onto or remain in or upon the public highway or right of way or onto, in or upon adjoining property.
- No gardener, landscaper or any person performing a gardening or landscaping function shall cause or permit anyone to spill or dump oil, gasoline or other petroleum products or any pesticides or other chemicals on a public highway or right of way or anywhere on the ground. No equipment shall be filled or refilled except over a drop cloth or other device designed to catch and retain any accidental spillage.
- No gardener, landscaper or any person performing a gardening or landscaping function shall burn any waste paper, rubbish, leaves, cuttings, wood or other waste materials.
- No gardener, landscaper or any person performing a gardening or landscaping function shall place any garbage, refuse, cuttings, leaves, wood or other materials or debris upon any public highway or right of way or upon any public or private place or property.
- No gardener, landscaper or any person performing a gardening or landscaping function shall drive commercial landscaping vehicles over the bridges at the Lakes.

### **VIOLATIONS - *subject to issuance of a appearance ticket, fine, and/or license being revoked, if :***

- Work is being performed without a License
- Stickers are not affixed to driver's side window of vehicle(s) and/or left fender of trailer(s) - **NON-TRANSFERABLE**
- Work is being performed outside the permitted times  
PERMITTED WORK DAYS/HOURS: Monday–Friday 8AM to 6PM and Saturday 9AM to 5PM  
(WORK PROHIBITED on Sundays & Federal Holidays)
- Work is obstructing traffic or endangering pedestrians (*i.e.*: DO NOT PARK facing wrong direction)
- Vehicles are parked on lake side of street at Lakes or bulkhead side of Concourse East & West (parking prohibited)
- Blowing leaves, grass clippings or other debris onto other properties or into road and/or storm drains is observed  
(all grass & landscape debris MUST be taken with you after the service)

***By signing this application the license holder agrees to abide by the applicable local laws and regulations.***

***HOLD Harmless/Indemnification agreement: The applicant shall indemnify and hold the Inc. Village of Brightwaters harmless against any claim of liability or loss including the cost of defense for personal injury or property damage resulting from or arising directly or indirectly out of , or resulting from, the license holder's or Licensee's operations within the Inc. Village of Brightwaters, including losses arising out of the negligent acts or omissions of the applicant, its servants or agents, and any subcontractors, its servants or agents.***

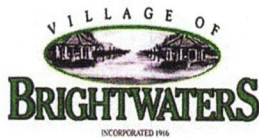
