

BRIGHTWATERS HARBOR 2024 RESIDENT RATES

Dear Resident:

Applications are now being accepted for the May 1st – Nov. 30th, 2024 boating season.

Applications must be received at the Village Office by April 5th. Slips will not be held/guaranteed for applications received after this date. Boat stickers will be mailed before opening of canal, which is April 15th!

Good news! There are 2 ways to submit Boat applications this year!

- 1) Completing the enclosed application, with copies of required documentation. OR
- 2) By using the new Mybrightwaters app, a very convenient way to complete the boat application upload required documents & convenience of paying online after approved! Scan the QR code to join and complete boat application.

(note: Mybrightwaters app is being launched village-wide; see enclosed flyer)

The enclosed application must be complete, signed and accompanied by:

- 1. Boat registration in boat owner's name.
- 2. Car registrations: two (2) resident vehicles maximum.
- 3. Proof of Residency <u>Utility bill</u> (PSEGLI, SCWA, Verizon), Homeowners Insurance in boat owner's name. <u>NOT A TAX BILL</u>
- 4. Certificate of liability insurance for \$100,000 in the boat owner's name and naming the <u>Village of Brightwaters</u> as <u>additional insured</u>.
- 5. Check payable to Village of Brightwaters for full amount.

(Sunfish/Kayaks/paddle boards)

Daily Canal Mooring Rate* * \$25.00 per day

If you have a berth preference, indicate the berth number, east or west side of the canal. Berth numbers are attached to the bulkhead. As soon as application is approved, you will receive a copy of a signed contract, Boat sticker, rules and regulations and **2** harbor-parking stickers for each of the vehicles on application.

^{**}The above fee is for boats brought in prior to the May 1st opening date without permission and if a boat is left in the canal after the harbor closes, November 30th.
